Subject:- GRANT OF PERMANENT ADVANCE IN RESPECT OF NCC DTES/GROUP HQ/UNITS/INDEPENDENT COMPANIES

Sir,

I am directed to refer to Govt of India, Ministry of Defence Letter No. 0952/DGNCC/P&F/Fin/Budget/309/D(GS-VI) dated 10/04/1992 and to convey the sanction of the competent authority for one time grant of permanent advance to NCC Dtes, Group HQs, Units and Independent Companies as follows:-

(a)	NCC Directorate	:	Rs. 10,000/-
(b)	NCC Group HQ	:	Rs. 20,000/-
(c)	NCC Unit	:	Rs. 10,000/-
(d)	Independent Coy	:	Rs. 4,000/-

2. The amount may be drawn by the NCC Dtes, Group HQ, Units and Independent Companies from their respective regional controllers of Defence Accounts. The amount may be utilized to meet expenses of the following nature:-

- (a) All types of expenses on training and administration. No pay and Allowances will be disbursed from this advance.
- (b) Advance of TA/DA in emergent and exceptional cases to Staff when there is no time to draw it from authority concerned.
- (c) Any contingent expenditure.

3. The amount spent from the permanent advance may be recouped from Centre's Budget or State's Budget as the case may be and will not be got recouped from CGDA as per Rule 226 of Regulations for the Unit Allowance of the Army.

4. Every Officer holding a permanent advance will, on the 1st Apr of each year, sent to the CDA an acknowledgement that the amount is due from and is to be accounted for by him, when relieved of his charge, he will account for the advance to his successor, this fact being recorded on the reverse of I.A.F.Z 2081.

5. The expenditure is debitable to Major Head 2076 (Army) Minor Head 113(NCC) Sub Head F.2 Code Head 1/552/02.


